Dear Ms Webb,

**Your recent correspondence with the Department of Communities and Justice**

We refer to your application for access to information under the *Government Information (Public Access) Act 2009 (GIPA Act)*, received by the Department of Communities and Justice (**Department**) on 25 October 2024. Please see **attached** valid acknowledgement letter for this application (our reference: GIPA24/4341).

In relation to your recent correspondence with the Department dated 25 October 2024, we advise you that:

- a. You are blocked from communicating with the Open Government, Information and Privacy Unit (**OGIP**) using email, as your correspondence has caused significant levels of stress and is perceived by OGIP staff to be defamatory, threatening, insulting, misleading and abusive.
- b. The only exception to point (b) is when you copy the Department in email correspondence required to be sent in the course of proceedings (as required by orders, directions or procedural requirements). I also note your current submissions for 2024/00361128 are due on 8 November 2024, which we will accept by email. There will be no other exceptions.

Under the *Work Health and Safety Act 2011 (NSW)*, I am obliged to appropriately respond to stress-related issues experienced by staff. Staff within OGIP have indicated that they perceive the content of your communications to be defamatory, threatening, insulting, misleading, abusive, and this has resulted in significant levels of stress.

Specifically, I note your recent access application dated 25 October 2024, includes the following false and defamatory statements we perceive to be made about OGIP staff:

- *'providing false and misleading information about unsuspecting members of the public'*
- *circulating 'false and misleading documents...to third party agencies and the NSW judiciary for the purposes of influencing key decision makers...'*
- *'initiat[ing] and implement[ing] agreements with interested third parties to falsely apply public interest considerations against disclosure of open access information mandated from release'*
- *'concealing and protecting information and influencing key decision makers.'*

There is no factual basis on which to make such statements against OGIP staff members, and this correspondence has caused staff members significant levels of stress.

On 29 June 2023, the Department sent you a letter (**attached**), asking you to cease any communication which is not respectful or likely to cause undue distress to staff. In that letter, we advised you that if you continue to behave in this manner, we would impose limits on your contact by restricting your contact to 'writing only by post'.

I am now compelled to take the next step and promptly deal with this issue to ensure the health and safety of OGIP staff is appropriately managed.

I advise that from today, any further email or electronic communication from you will be blocked and deleted without being read (with the exception to the above at point (b)), and correspondence will only be accepted by staff of OGIP if it is delivered by Australia Post.

This includes any emails or electronic communication sent to other employees/business units within the Department that are aimed to circumvent the restriction. This restriction will apply to any email or electronic communications sent by any person we believe may be acting in concert with you.

The restriction we now place on your email/electronic contact applies to emails received from [info@nswfreedomofinformation.net](mailto:info@nswfreedomofinformation.net) and any other email address you have used previously or may create in future.

The limitation on your access to emailing staff of OGIP will remain in effect for 12 months, at which time I will assess whether there is any demonstrated need to extend it for a further period.
